#### **ABSTRACT**

This article explores how the song The Night We Met by Lord Huron evokes varied emotional responses from listeners through the lens of Saussure's semiotics. By analyzing the lyrics as signs composed of signifiers (words) and signified (emotional meanings), this study reveals the song's ability to resonate universally across themes of love, memory, and loss. The research employs a qualitative descriptive method, gathering data from listener responses on social media platforms like Instagram, TikTok, and YouTube. The findings indicate that the song elicits diverse emotions, such as nostalgia, longing, and regret, depending on individual interpretations. Through its poignant lyrics and symbolic depth, The Night We Met demonstrates music's capacity to connect deeply with human experiences, making it a powerful medium for emotional expression and reflection.

### **INTRODUCTION**

Music has long been a powerful medium for conveying complex emotions, particularly regarding themes of love, loss, and memory. As humans, we are deeply connected to the emotions that music evokes, especially through song lyrics that resonate with our personal experiences. Love, in particular, is an emotion that defies simple definition due to its complexity. In relationships, love manifests in various forms: joy, sorrow, longing, and heartbreak. These multifaceted emotions make love a complicated experience, often leaving individuals feeling vulnerable and sensitive to relationship-related events. Songs that explore these emotional dimensions can speak to listeners on multiple levels, providing a space for reflection on their own experiences with love.

Music videos and lyrics serve as mediums for visual and emotional storytelling. According to Syamsurrijal et al. (2024), video clips convey "moral, religious, social criticism, and propaganda messages," illustrating how visual and lyrical narratives can amplify the emotional impact of music. Similarly, the song *The Night We Met* by Lord Huron exemplifies how music can encapsulate emotions of both nostalgia and regret. Released in 2015, the song gained widespread recognition after being featured in the popular Netflix series 13 Reasons Why, where its haunting melody and poignant

lyrics resonated deeply with viewers. The lyrics reflect a profound yearning to return to a moment in the past when everything seemed perfect, yet they also carry a deep sorrow for what has been lost. The refrain "take me back to the night we met" captures the essence of this longing, evoking feelings of wanting to relive a moment of love before it slipped away. This desire is rooted in the painful realization that cherished memories can never be fully reclaimed. However, the ambiguity of the lyrics allows for multiple interpretations, as different listeners may connect with the song in diverse ways depending on their personal experiences.

The emotional depth of The Night We Met lies in its ability to evoke a wide range of responses from listeners. For some, the song serves as a nostalgic reflection on a perfect moment in a relationship that they wish they could revisit. The poignant lyrics "I had all and then most of you, some and now none of you" illustrate the painful shift from having a partner's love and presence to losing them entirely. This stark contrast between the fullness of a past relationship and the emptiness left behind resonates deeply with those who have experienced heartbreak and loss, encapsulating the feeling of longing for a love that was once whole.

Conversely, other listeners interpret the song as a desire to undo the past and prevent the heartbreak altogether. The line "so I can tell myself what I'm supposed to do" suggests a wish to return to that pivotal night to change the course of events, perhaps to avoid the relationship entirely if it means sidestepping subsequent pain. This duality in interpretation highlights the song's emotional complexity: it speaks both to the beauty of a cherished love and the overwhelming pain of losing it. It captures a powerful emotional paradox: standing at a crossroads where love meets loss, unsure if you're walking away from the best or worst thing that ever happened to you.

Song lyrics, much like poetry, serve as a reflection of the human experience. The language used in The Night We Met is rich with emotional connotations, creating vivid imagery that resonates deeply with listeners (Sitorus and Herman 2019). They argue that song lyrics are a means of communicating thoughts and emotions, providing listeners with a way to process their feelings through music. The lyrics of The Night We Met serve as a bridge between the composer's emotions and the listener's personal interpretation, allowing for a shared emotional journey.

In analyzing the lyrics of "The Night We Met", it becomes evident that they function as a form of literature, employing metaphor and symbolism to convey complex emotional states. The recurring refrain "take me back to the night we met" serves as a powerful symbol of nostalgia and longing, while other lines, such as "I had all and then most of you," depict the progression of loss and the resulting emotional void. As literature allows for multiple interpretations, so too do song lyrics like these invite listeners to project their own emotions and experiences onto the words, creating a deeply personal connection to the music. The song embodies an emotional struggle where the desire to hold onto the past clashes with the painful reality of moving forward. This article aims to explore how the lyrics of The Night We Met evoke varied emotional responses from listeners, revealing the song's emotional depth and its capacity to resonate on a universal level.

Semiotics is the study of signs and symbols as elements of communicative behavior. According to Ferdinand de Saussure, a foundational figure in this field, signs are fundamental components of social life, consisting of two parts: the signifier

and the signified. This duality allows us to understand how meaning is constructed and interpreted within language and communication. Although Saussure himself did not publish a formal book, his lectures were compiled by his students, outlining the key principles of his theories, which have become essential to understanding the relationship between language, meaning, and interpretation.

In semiotic terms, the signifier refers to the physical form of a sign, such as the words of a song, while the signified is the concept or meaning that those words evoke. This dyadic relationship is crucial for analyzing song lyrics, as it reveals how language can represent complex emotional states. In The Night We Met, the lyrics serve as signs that encapsulate emotions of longing and regret, allowing listeners to connect their personal experiences with the meanings conveyed through the song. The essence of semiotics lies in understanding how signs function within social contexts to create meaning. Semiotics can encompass various sign systems, including language, visual imagery, and sounds (Sitorus and Herman 2019). In this analysis, the song lyrics are viewed as indicators of deeper emotional truths, inviting listeners to interpret their meanings based on their individual perspectives. Assertion that semiotics extends to literary analysis, where language generates multiple meanings through the interplay of signs (Lestari 2023).

In exploring the lyrics of "The Night We Met", we observe a range of emotions embedded in the signifier, which includes the specific words and phrases used in the song. For instance, the repeated line "take me back to the night we met" functions as a poignant signifier of nostalgia and longing. The signified in this context reflects the desire to revisit a perfect moment in the past, highlighting the emotional complexity that accompanies memories of love and loss. The relationship between the signifier and the signified is intimate; one cannot exist without the other (Josephson, Kelly, and Smith 2020). The signifier represents the mental image of sound, while the signified embodies the mental comprehension of that significance (Farias, Blok, and Roberts 2019). This close relationship allows listeners to engage deeply with the lyrics, projecting their own feelings of love, heartbreak, and longing onto the music. This study aims to analyze how the lyrics of The Night We Met convey complex emotional responses from listeners. By examining the signifiers and signified present in the lyrics, we can uncover the underlying meanings of love, memory, and loss that resonate universally, illustrating the song's ability to evoke varied emotional interpretations.

#### **METHOD**

This research employs a qualitative method to analyze the lyrics of the song "The Night We Met" by Lord Huron through a semiotic lens. The qualitative descriptive research method is chosen because it focuses on analyzing textual data, aligning with (Silverman 2013) approach where the data appears in the form of words rather than numbers. The research data comprises listener responses to the song, gathered from social media platforms such as Instagram, TikTok, and YouTube. These platforms were selected because they provide access to real-time public opinions, emotional reactions, and varied interpretations of the song. The data was systematically collected and categorized based on emotional responses expressed in comments, reviews, and posts. The process followed (Creswell 2018) recommendation for qualitative research, where data is analyzed without statistical measures but through thematic

interpretation. The researcher employed the following steps: (1) data collection, (2) categorization of lyrics, (3) interpretation of emotional responses, and (4) drawing conclusions.

A semiotic analysis, based on Saussure's theory of signifiers and signifieds, was applied to the lyrics. Specific lines of the song that were frequently referenced in social media discussions were selected for detailed analysis. These key lyrics were examined for their symbolic meaning (signifier) and their emotional significance (signified) as expressed by listeners. This approach allowed the researcher to interpret how different lyrics evoke varying emotional responses, such as sadness, nostalgia, and longing. The data was organized in a table, with the lyrics in one column and the associated emotional interpretations and listener comments in the other. The conclusions were drawn from this analysis, reflecting the diverse emotional impact of "The Night We Met" on its audience.

#### FINDINGS AND DISCUSSION

#### Signifier and Signified

In this analysis, the relationship between the signifier (the word or symbol used) and the signified (the concept or idea represented by the signifier) is explored through the song "The Night We Met." Using Saussure's semiotic theory, the lyrics are examined for their deeper meanings. The signifier is represented by the words and phrases in the song, while the signified is the emotional and mental image or concept that the words evoke.

In this context, the signifier and signified are intricately linked, as the words in the song (the signifiers) trigger emotional responses and memories, which in turn represent the signified — the longing, pain, and nostalgia that arise from the narrator's desire to return to a pivotal moment in the past.
